

SOUTH DAKOTA HIGH SCHOOL ACTIVITIES ASSOCIATION REGULAR MEETING OF THE BOARD OF DIRECTORS SDHSAA OFFICE BUILDING

November 5, 2025 10:30 AM CT Pierre, South Dakota

The Board of Directors held a regular meeting on November 5, 2025 at the SDHSAA Office Building in Pierre, South Dakota with members present as follows:

The meeting was called to order by President Jeff Danielsen at 10:31 A.M., followed by the pledge of allegiance.

Item #1-Approval of Agenda

Item #7- Policy Readings regarding spectators entering the playing area prior to awards.

The Board discussed some policy possibilities regarding this topic and held a first reading on the following policy:

SDHSAA Arena Rules item 14, page 26 in general section of handbook and all other references within the SDHSAA Athletic Handbook.

14. All fans will be expected to remain off the playing floor until after the awarding of medals and trophies. Failure to remain off the playing floor will result in the offending team not being recognized by the public address announcer. Medals and trophy will be awarded to school personnel following the awards ceremony. Any fans who enter the playing area prior to the awarding of medals and trophies will be removed from the facility immediately. Any physical altercations between fans and players will be referred to security/law enforcement. No awards or trophies will be handed out until the floor is cleared. Fans will be allowed on to the playing floor following the presentation of all awards in facilities where this is allowed. Enforcement of this policy is the responsibility of each school's administration at the event. The Board reserves the right to issue penalties to schools who blatantly disregard this policy.

NOTE: This policy is applicable to football, volleyball, and basketball, soccer, dual wrestling, and softball. No fans are allowed on the field at the football championships at any time per facility rules. In basketball, volleyball, soccer, dual wrestling, and softball, fans are only allowed on the playing surface after the championship contest awards and only in facilities that allow it.

Item #7.5- Rapid City Stevens request to change dates of basketball tryouts

Motion by Long, second by Clanton, to approve the switch from the previously approved dates of November 21, 22, and 24 to the new requested dates of November 19,20, 21.

Motion carried 6-0.

Item #8- SDHSAA Classified Staff Policy Amendment

Motion by Bauer, second by Rollinger, to approve the classified policy change as requested, changing the vacation leave after 7 years from 18 days/144 hours to 20 days/160 hours.

Motion carried 6-0.

Item #9- Student Council Convention change

Motion by Kosters, second by Long, to approve a change of the State Student Council convention to a 7-12 event for 7-12 student council programs and to eliminate the separate middle school event.

Motion carried 6-0.

Item #10 – Udpated State Track and Field Meet Schedule

Motion by Rollinger, second by Clanton, to approve the 2026 State Track and Field Meet schedule changes. Schedule can be found attached to the November 5 agenda Item 10 or on the Track and Field section of the SDHSAA handbook.

Motion carried 6-0.

- Jeff Kosters appreciated the All-State Chorus and Orchestra concert, noted how quickly the fall has passed, and made some inquiries/suggestions regarding the awards order at Cross Country.
