## **Officiating Philosophy**

**Be Safe**: Safety – for athletes, officials, coaches, fans, and media – is the number one priority. Safety is the responsibility of EVERY OFFICIAL! Be proactive in promoting safety and make sure proper safety protocols are followed. Do not be timid if you see unsafe situations or if others are not being vigilant.

**Be Fair**: Know the appropriate rules for the meet and the event you are officiating and apply them consistently. Don't make up rules. No athlete should be allowed to gain an unfair advantage and no athlete should have to suffer an unfair disadvantage. All athletes should be regarded as equals, regardless of ability, the level of competition or who they represent.

#### SDCCTFOA Membership Meeting, July 17, 2024

On July 17, 2024, the SDCCTFOA held its second full membership meeting. Among the topics discussed were fees for track and field meets and cross country meets, possible ways to recognize the contribution of officials, the selection of state meet officials, SDHSAA official's uniform, possible rule/policy changes such as use of colored cards for start line violations, and colored flags for field events and umpires, and various issues with track facilities (sand in pits, track markings, throwing ring improvements, etc). #### **2024 Cross Country Rule Changes and Points of Emphasis**

There are no new cross country rules this year, however a point of emphasis is safety, and Rule 8-1 was reorganized, with emphasis on safety. There is an emphasis on clear course markings being continuous throughout the course, and both artificial and natural boundaries can be used as course markers. Flags, caution tape and rope or other similar materials are allowed as well. Make sure you survey the entire course prior to the race.

The 2024 State Cross Country Meet for all classes will be held on October 26, 2024 at the Hart Ranch Camping Resort just outside Rapid City, SD. ## **2024 Cross Country Meet Officiating**

SDHSAA cross country meets must be officiated by a SDHSAA register official. We are encouraging schools to hire a second official, but if only one is hired they serve as both the meet referee and starter. We expect the official to arrive an hour before the first race, attired in the official uniform.

It is imperative the official travel the course to ensure it is marked properly and free of unsafe conditions. To do so, make sure the school has a golf cart available for the referee for the entire meet. Check the starting area and assure there are an adequate number of starting boxes. Mark the 100 meters for recalls. Check to see the set up for the chute/corral at the finish line.

30 to 45 prior to the first race, conduct a coach's meeting to cover uniforms, sportsmanship, receive physician's statements and handle other administrative duties. During the meet, at the start line, check for uniform compliance, and conduct a fair start. Be on the course during the race, particularly at locations where runners could potentially cut off distance. Be sure to be at or near the finish line at the conclusion, as most violations occur near that point, and be prepared to sort out the order of finish if there is a dispute.

#### **SDCCTFOA 2025 Clinic Topics, Dates and Locations**

Beginning with the 2024 Track & Field season, a clinic or jamboree is required for SDHSAA registered track and field and cross-country officials. A new official is required to attend a clinic in their first or second year, and current officials are required to attend a clinic every three years to maintain their registered status. To fulfill this requirement, SDCCTFOA will present a track & field clinic before the track season. Those clinics are in-person presentations. Regional Representatives are responsible to host the meeting for the purpose of presenting a clinic in their respective area. Track coaches and athletic directors will be invited to the clinic.
